KNOW ALL MEN BY THESE PRESENTS, that Milton T. Smith

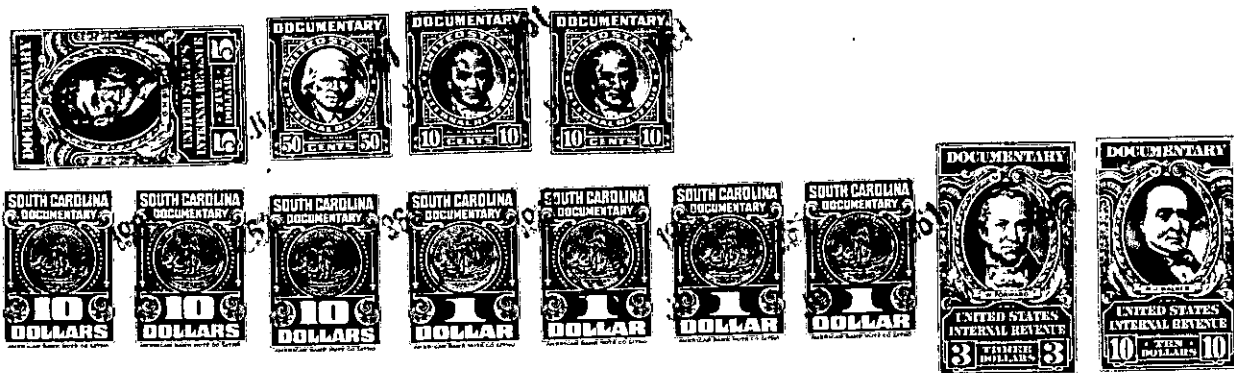
in consideration of Seventeen Thousand and No/100 (\$17,000.00)-----Dollars,

All that certain parcel or lot of land containing 4.58 acres, more or less, situated on the north side of the Brushy Creek Road, near Brushy Creek Baptist Church, Chick Springs Township, Greenville County, South Carolina, and having courses and distances according to survey and plat of the property of Eugene E. Hammett by H.S. Brockman, registered Surveyor, dated Dec. 15, 1955, as follows, to-wit:

BEGINNING at a nail in the center of the Brushy Creek Road iron pin on north bank at 24 feet, and running thence along the line of the W.H. Hammett property, N. 42-22 W. 370 feet to an iron pin; thence S. 57-12 W. 274.5 feet to an iron pin; thence S38-15 W. 301 feet to an iron pin on the Ross line thence along the Ross line, S. 35-50 E. 100 feet to an iron pin at the branch; thence S. 42-22 E. 168 feet to the center of the Brushy Creek Road, iron pin back on bank at 20 feet; thence along the center of the Brushy Creek Road, N. 58-42 E. 327 feet and N. 55-27 E. 260 feet to the beginning corner.
