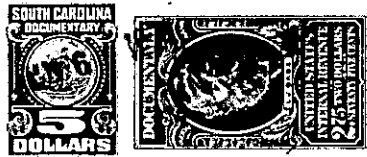

ALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #25, of a subdivision known as Pinehurst, Section 2, property of W. J. Burty, plat of which was prepared by J. Mac Richardson, March 1960, and recorded in the R.M.C. BEGINNING at an iron pin on the eastern side of Vista Drive, the joint front corner of lots #25 and #24, and running thence along the line of these lots, N. 45-48 E. 180.2 feet to an iron pin in the subdivision property line; thence along the subdivision property line S. 53-30 E. 57.8 feet to an iron pin; thence continuing along said property line S. 18-34 E. 67.6 feet to an iron pin at the joint rear corner of lots #25 and #26; thence S. 56-24 W. 181.3 feet to an iron pin on the eastern side of Vista Drive; thence along the eastern side of Vista Drive, N. 32-30 W. 86.6 feet to an iron pin, point of beginning.
