unto Jerry C. McNeely and Doris V. McNeely, their heirs and assigns,

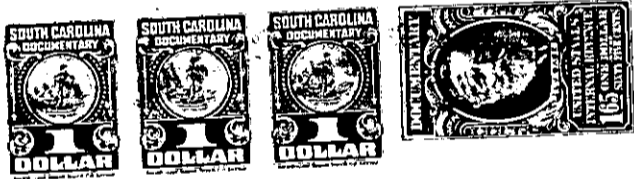
All that piece, parcel or lot of land, with the buildings and improvements thereon, situate,

metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Sewanee Avenue, joint front corner Lots 47 and
48, and running thence N. 84-34 E. 193 feet to an iron pin; thence N. 50-26 W. 113 feet to
