That We, F. B. & I. V. Edwards

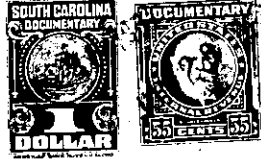

Morris Barton, his heirs, and assigns forever:

All that piece, parcel or lot of land in O'Neal Township, Greenville, County, State of South Carolina, being a portion of land formerly owned by J. F. Ballenger, located about five (5) miles North of Greer, being known and designated as Lot # 2, as shown on plat of property of grantors prepared by J. Q. Bruce, R. S., and being more particularly described as follows:
