WARRANTY DEED RESERVING A LIFE ESTATE

KNOW ALL MEN BY THESE PRESENTS, That, I, BUENA VISTA WATSON, (also know as BUENA VISTA WOOD WATSON, BUENA V. W. WATSON, MRS. J. H. WATSON AND MRS. J. HUMBERT WATSON, the widow of JOHN H. WATSON, deceased, in the State aforesaid, for and in consideration of the sum of Ten and no/100 DOLLARS (\$10.00) to me in hand paid before the sealing of these Presents, by FRANCIS E. WATSON, in the State aforesaid (the receipt whereof is hereby acknowledged), have granted, bargained sold and released, and by these Presents do grant, bargain, sell and release untosaid FRANCIS E. WATSON, his Heirs and Assigns, forever the following described real estate, to wit: All that certain piece, parcel or tract of land lying, being and situate in the First Ward of The City of Greenville, Greenville County, State of South Carolina, at the Southwest corner of Buncombe and Frank Streets, and more particularly described as follows:

Beginning at a nail on top of a masonry wall at the said corner of said streets thence N. 29°35' W. 88.5 feet to an iron pin; thence N. 25°58' W. 87.7 feet to a punch hole on top (front) of said wall; thence S. 57°15' W. 162.05 feet to an iron pin; thence S. 34°00' E.175.5 feet to an iron pin; thence N. 57°15' E.143 feet to the point of beginning, being Lot No. 1 and Lot No. 2 of the Plat of the Property of Buena Vista Watson, Olin W. Watson, Francis E. Watson, and David E. Watson, prepared by Pickell & Pickell, Registered Engineers, Greenville, S. C., dated 5 November 1959.
