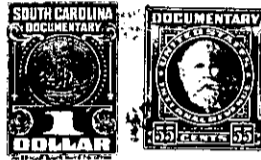
That We, F. B. Edwards & I. V. Edwards

All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, being a portion of land formerly owned by J. F. Ballenger, located about five (5) miles North of Greer, being known and designated as Tract # 18, as shown on a plat of property prepared for grantors by J. Q.
