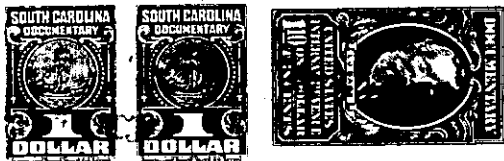
That We, F. B. Edwards & I. V. Edwards
