That I, J. Frank Williams

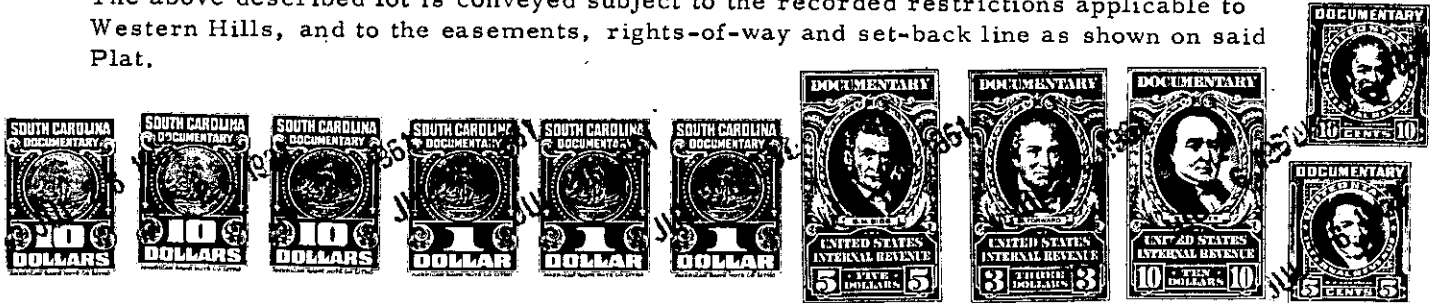
in the State aforesaid, in consideration of the sum of Sixteen Thousand Five Hundred (\$16,500.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William L. Campbell, Jr., their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 65 on Plat of Western Hills recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 98-9 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Tucson Drive, at the joint front corner of Lots Nos. 65 and 66, and running thence with the common line of said Lots, N. 26-08 W. 162.6 feet to an iron pin; thence N. 68-24 E. 100.9 feet to an iron pin; thence N. 78-44 E. 11.6 feet to an iron pin, the joint rear corner of Lots Nos. 64 and 65; thence with the common line of said Lots, S. 21-43 E. 153 feet to an iron pin on the northerly side of Tucson Drive; thence with said Drive, S. 65-17 W. 75.5 feet to an iron pin; thence continuing with said Drive, S. 63-17 W. 24.5 feet to the point of beginning.

The above described lot is conveyed subject to the recorded restrictions applicable to Western Hills, and to the easements, rights-of-way and set-back line as shown on said Plat.
