in consideration of the sum of One Thousand and no/100 DOLLARS,

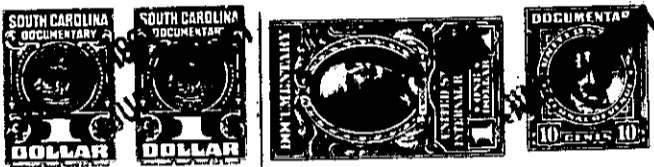

All that lot of land in the County of Greenville, State of South Carolina, in Bates Township, near Travelers Rest, known as lot 20 on plat of Montevideo, recorded in plat book KK at page 102, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of East Scenic Drive at the corner of lot 19 and running thence S 88 W, 200 feet to an iron pin; thence along the line of lot 14, S 2 E, 100 feet to an iron pin; thence along the line of lot 21 N 88 E, 200 feet to an iron pin on the western side of East Scenic Drive; thence with said Drive, N 2 W, 100 feet to the point of beginning and being a portion of that property conveyed to us in deed book 538 at page 82.
