KNOW ALL MEN BY THESE PRESENTS, that I, Levis L. Gilstrap

in consideration of Thirty three Hundred & 88 (3388.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Joseph A. Whitt, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 1 of a subdivision known as Maple Heights, being the property of Marshall F. Vaughan, according to a plat thereof prepared by C. C. Jones, C. E., June, 1954 and recorded in the R. M. C. Office for Greenville County in Plat Book HH, at page 49, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of Keith Drive, joint front corner of Lots 1 and 2, which point is approximately 610.3 feet north from the intersection of Keith Drive and Lowndes Hill Road, and running thence with the joint line of Lots 1 and 2, S. 46-50 W. 111.4 feet to an iron pin on the rear line of Lot 15; thence with the rear line of lots Nos. 15 and 16, N 34-39 W. 108.4 feet to an iron pin at the rear corner of lot No. 16; thence N. 62-15 E. 102 feet to an iron pin on the southwest side of Keith Drive; thence with Keith Drive, S. 41.00 E. 80 feet to the beginning corner.

The grantee assumes and agrees to pay the balance due on the mortgage by the grantor to General Mortgage Company recorded in Mortgage Book 622, page 287, the balance now due and owing being \$6,416.88.
