in consideration of the sum of Four Thousand (\$4,000.00) ----- in the State aforesaid, DOLLARS,

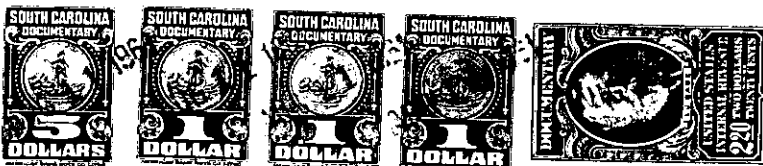

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 39 on Map No. 2 of Liberty Park subdivision, made by Dalton & Neves, August 1958 recorded in the RMC Office for Greenville County, S. C., in plat book MM page 39 and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the north side of Valerie Drive, the joint front corner of Lots 38 and 39; thence with the joint line of said lots N. 18-41 W. 165.1 feet to an iron pin in line of Lot No. 37; thence with the line of said lot and the rear line of lot No. 36, N. 66-42 E. 70 feet to an iron pin corner of Lot No. 40; thence with the line of said lot S. 42-19 E. 156 feet to an iron pin on the north side of Valerie Drive; thence with the curve of said Valerie Drive S. 56-39 W. 115 feet to a point; thence continuing with the north side of Valerie Drive S. 74-44 W. 21.2 feet to the beginning corner.

This lot is conveyed subject to building restrictions applicable to said subdivision recorded in deed book 613 page 561 and to recorded easements.
