

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate on the Northeast side of Blackburn Street, in the City of Greenville, in Greenville County, South Carolina, shown as Lot 16 on plat of Isaqueena Park, made by Pickell & Pickell, Engineers, June 3, 1947, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book P, at Pages 130 and 131, said lot being described on a survey made by R.K. Campbell, Surveyor, August 2, 1961, as follows:
