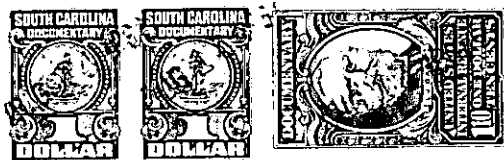
All that certain piece, parcel or lot of land, lying and being on the westerly side of Heathwood Circle, near the town of Taylors, South Carolina, being shown as Lot 74 on the plat of Heathwood as recorded in the RMC Office for Greenville County, S. C., in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Heathwood Circle at the joint front corner of Lots 74 and 75 and running thence along the joint line of said lots S 37-12 W 201.7 feet to an iron pin, the joint rear corner of Lots 74 and 75; thence N 45-20 W 20 feet to an iron pin; thence N 23-53 W 112 feet to an iron pin, the joint rear corner of Lots 73 and 74; thence along the joint line of said lots N 60-24 E 201 feet to an iron pin on the westerly side of Heathwood Circle; thence with the westerly side of Heathwood Circle S 30-53 E 100 feet to the point of beginning.
