. The following protective covenants and restrictions are hereby imposed upon and shall apply to Lots # 3 through # 9 and Lots # 11 through # 20 of

the subdivision described hereinabove:

(1) The aforesaid designated lots shall be used for residential purposes only, and no structure of a temporary character, trailer, basement, tent, shack, garage apartment, garage, barn or other outbuilding shall be used on any designated lot at any time as a residence either temporarily or

permanently.

(2) No dwelling shall be permitted on any of the designated lots of which the ground floor of the main structure, exclusive of open perches and

garages, shall contain less than 800 square feet of floor space.
(3) No building shall be erected or placed on any of the designated lots unless the same shall be underpinned with either brick or concrete block. (4) No building shall be located on any of the designated lots nearer to the front lot line or street line than the distance of 45 feet from said front or street line.

(5) Easements for the installation and maintenance of utilities and drainage facilities, and rights-of-way for streets or roads are hereby reserved as shown on the recorded plat or as set forth in any recorded instru-
