HILLCREST MEMORIAL MAUSOLEUM CERTIFICATE OF OWNERSHIP

KNOW ALL MEN BY THESE PRESENTS:

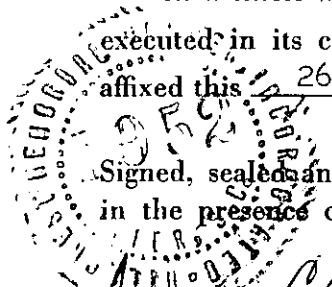
That Hillcrest Memorial Garden, a corporation organized under the laws of the State of South Carolina, the owner of Hillcrest Memorial Garden and Hillcrest Memorial Mausoleum, in consideration of the sum of Nine Hundred Fifty and----- no/100-----Dollars to it in hand paid, receipt of which is hereby acknowledged, does hereby grant and convey unto Dwight L. and Edna J. Harrison, their-----, heirs and assigns,

subject to the conditions, reservations and restrictions hereinafter referred to, the right of intombment or inurnment in the following Space(s) of Hillcrest Memorial Mausoleum in the process of being constructed, or already constructed, in Hillcrest Memorial Garden in the County of Spartanburg, State of South Carolina, described as: 2 CRYPTS, NICHES, FAMILY ROOM, and more particularly shown upon a plan of said Mausoleum filed in the office of Hillcrest Memorial Garden as:
Section Lettered "B" Tier No. 3 Crypt Number 300
Section Lettered Tier No. Crypt Number
Niches Tier No. Room Lettered

That This Conveyance, and all right and interest hereby conveyed is, and at all times shall be, limited to a right of intombment or inurnment of members of the Caucasian Race only therein, and is subject at all times to the rules and regulations and bylaws of said corporation on file in its office now existing and/or which may be hereafter adopted either by amendment, alteration, or the adoption of new ones, and which are specifically referred to and herein inserted as if set forth in full; all of which are conditions, reservations and restrictions, binding upon the grantee, his heirs, executors, administrators, devisees and assigns.

That nothing herein contained shall be deemed to restrict the use of any other portion of Hillcrest Memorial Garden or Hillcrest Memorial Mausoleum. Only the grantor or its successors in interest of the fee title may enforce any restrictions heretofore or hereafter placed upon the use of any portion or section of said Garden or Mausoleum; that no transfer of any portion or division of the space herein specified shall be valid until recorded in the office of the corporation.

In Witness Whereof, said Hillcrest Memorial Garden has caused these presents to be executed in its corporate name by its President, and its corporate seal to be hereunto affixed this 26th. day of June, 1961.
