MOSELEY, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 35 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Salem Court at the joint front corner of Lots 34 and 35 and running thence with the Southeastern side of Salem Court S 34-52 W 100 feet to a point at the joint front corner of Lots 35 and 36; thence S 55-08 E 190.9 feet to a point at the joint rear corner of Lots 35 and 36; thence N 20-55 E 103 feet to a point at the joint rear corner of Lots 34 and 35; thence N 55-08 W 166.1 feet to the point of beginning.
