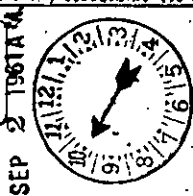

ALL of my right, title and interest in all that certain, piece, parcel or lot of land situated in Chick Springs township, in the State and County aforesaid and having the following metes and bounds, to-wit:

BEGINNING at the intersection of two unnamed streets and runs thence with one of these streets S. 14.45 W. 55 feet to the corner of lot No. 6; thence along the line of lot N<sup>o</sup>. 6 60-37 E. 150 feet to the line of lot No. 8; thence along this line N. 14-23 E. 55 feet to the other unnamed street; thence along this street N. 60-37 W. 150 feet to the beginning corner, being designated as lot No. 5 on the subdivision of the R.
