the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Thelma Lee Watson Williams, her heirs and assigns,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, the City of Greenville, on northern side of South Woodside Circle, now also known as Ashley Avenue, being shown and designated as Lot Number Three (No. 3) on a plat of the property of L. O. Patterson, prepared by Dalton & Neves, Engrs., in October 1925, recorded in the R.M.C. office for Greenville County, S. C., in Plat Book "T" at page 131, and, according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point, iron pin, in northern side of said South Woodside Circle, or Ashley Avenue, joint front corner with Lot No. 2 of said plat heretofore conveyed to Ella Mae Long, and running thence with the line of said Lot No. 2, N. 28-54 E. 116.7 feet to a point, iron pin, joint rear corner of Lots Nos. 2, 3, 4 and 5; thence with the rear line of Lot No. 4, S. 74-00 E. 65.4 feet to a point, iron pin, in the western side of an unnamed Street; thence along the western side of said unnamed Street, S. 28-54 W. 100 feet to a point, iron pin, at intersection with South Woodside Circle, or Ashley Avenue; thence N. 87-00 W. 71 feet along the northern side of South Woodside Circle, or Ashley Avenue, to point of beginning.
