To manufacture, buy, sell, distribute, import, export, lease, exchange, install, repair, and otherwise trade and deal in and with, at wholesale or retail or both, as principal, agent, broker, distributor, dealer, jobber, manufacturer or otherwise, any and all kinds of machinery, machines, tools, dies, jogs, fixtures, devices, equipment, implements, appliances, accessories, parts, supplies, goods, wares, merchandise and personal property of every class and description;

To exercise all the powers conferred by the laws of South Carolina upon corporations former under the act hereinafter referred to, and to do any or all things hereinbefore set forth to the same extent as natural persons might or could do.
