the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto David P. Reese and Mary G. Reese, their heirs and assigns forever,

All that lot of land situate on the North side of Rockingham Road in Greenville County South Carolina, being shown as LOT NO. 41 ROCKINGHAM ROAD on plat of Barksdale subdivision, made by Dalton & Neves, Engineers, December 1959, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book QQ, pages 118 and 119, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Rockingham Road, joint corner of Lots 41 and 43 and running along the line of Lot 43, 42 and 15 N. 31-57 W. 328.4 feet to an iron pin; thence along the rear line of Lot 16 S. 55-57 W. 139.9 feet to an iron pin; thence S. 31-04 E. 278.4 feet to an iron pin on Rockingham Road, joint front corner of Lots 40 and 41; thence along Rockingham Road N. 74-27 E. 21 feet to an iron pin; thence N. 75-40 E. 129.5 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 648, at Page 453.
