

Also all that piece, parcel or lot of land situate, lying and being in Chick Springs Township, County of Greenville, State of South Carolina, about two miles North of Pelham, South Carolina, on the western side of Greer-Pelham Road, bounded on the East by said Greer-Pelham Road and by property now or formerly belonging to Mary E. M. Bridges and to E. L. Mayfield, on the South by property now or formerly belonging to Nellie B. M. Green, on the West by property now or formerly belonging to E. L. Mayfield and to James L. Knight, on the North by property now or formerly belonging to James L. Knight, being known and designated as Tract No. 3 as shown on a plat entitled "Property of W. P. Mayfield", prepared by H. S. Brockman, Surveyor, dated October 26, 1943, and also as Tract No. 156 as shown on a plat entitled "Property Ownership Map Prepared for Greenville-Spartanburg Airport Commission", dated June 23, 1960, prepared by Piedmont Engineering Service, and having, according to a more recent plat entitled "Property of Margaret Ruth M. Mathis", compiled by Piedmont Engineering Service, dated March , 1960, the following metes and bounds, to-wit:

BEGINNING at an iron pin in or near said Greer-Pelham Road at the joint corner of the within described premises and property now or formerly belonging to Mary E. M. Bridges, and running thence with said Greer-Pelham Road and the line of said Bridges property and the line now or formerly belonging to E. M. Mayfield, the following courses and distances: S. 5-45 E. 88.5 feet, S. 9-55 E. 100 feet, S. 15-35 E. 100 feet, S. 22-25 E. 100 feet, S. 27-05 E. 100 feet, S. 34-45 E. 100 feet, S. 36-45 E. 100 feet, S. 37-45 E. 100 feet to an iron pin in the line of property now or formerly belonging to Nellie B. M. Green; thence with the line of said Green property S. 76-25 W. 447 feet to an iron pin in the line of property now or formerly belonging to E. L. Mayfield; thence with the line of said Mayfield property N. 1-30 W. 216.5 feet to an iron pin in a line of property now or formerly belonging to James L. Knight; thence with the line of said Knight property N. 89-50 E. 202 feet to an iron pin; thence continuing with the line of said property N. 10-30 W. 615 feet to an iron pin; thence still continuing with the line of said Knight property S. 68-38 E. 31 feet to the point of beginning.
