Jack H. Gunnells, his heirs and assigns forever:

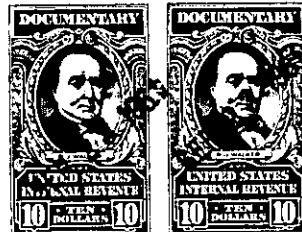
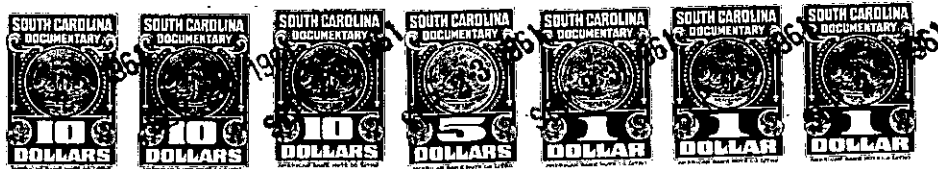

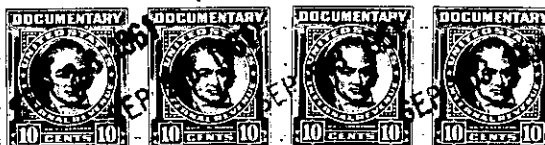
