 and the exchange of real estate valued at \$3,500.00
 to us in hand paid at and before the sealing of these presents
 by Thomas Walter Brashier and W. F. McKinney

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
 these presents do grant, bargain, sell and release unto the said Thomas Walter Brashier
and W. F. McKinney, their heirs and assigns forever:

all that piece, parcel or lot of land in Paris Mountain Township, Greenville
 County, State of South Carolina, located on the Western side of the Davidson
 Road and the Southern side of the North Parker Road, and being shown
 as all of lots SIX (6), SEVEN (7), EIGHT (8), NINE (9) and the greater
 part of lot number TEN (10) on a plat of property made for Dit White
 Poe, by J. C. Hill, surveyor, dated Aug. 26, 1947, and has together
 the following metes and bounds, to wit:

Beginning at a nail and cap in the center of the said Davidson Road
 at the joint front corner of lots 5 and 6 and runs thence as the common
 line of said lots, N. 64-30 W., 837.1 feet to an iron pin joint rear
 corner of said lots; thence S. 36-15 E., 667.4 feet to an iron pin at
 the north rear corner of lots 8; thence S. 53-00 E., 527.1 feet to an iron
 pin at the corner of lot 9; thence N. 34-30 E., 492 feet to the center
 of county road (North Parker Road); thence with the center of said road
 Southeast 250 feet more or less to a point in the center of said road
 and Davidson Road; thence S. 41-45 W., 150 feet more or less to an
 iron pin at the joint front corner of lots 9 and 10; thence still with
 Davidson Rd., S. 41-45 W., 416.9 feet to an iron pin in the front line
 of lot 7; thence S. 12-30 W., 275 feet to an iron pin in Davidson Rd.,
 thence S. 19-45 W., 69.3 feet to the beginning corner.

 adjoining the above described property on the rear of lot No. 8, and
 being the Northeastern part of Lot Number SIX (6) on a plat of property

Beginning at an iron pin at intersection of two roads at corner of lots
 6 and 8 on said plat and runs thence S. 26-15 E., 227 feet to an iron
 pin on the line of the property formerly of Dit White Poe; thence with
 the Poe line S. 37-15 W., 22.6 feet to an iron pin in the rear line of
 lot 6; thence N. 26-15 W., 255.1 feet through lot 6 to center of road;
 thence S. 65-30 E., 26.7 feet to the beginning corner. (over)
