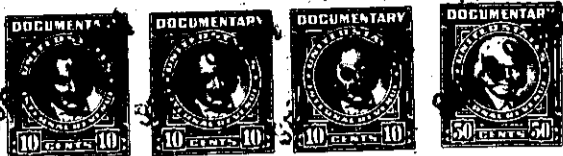

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said SYLVIO JOSEPH DeSALVO, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, lying on the southern side of Fleetwood Drive, in Gantt Township, near the City of Greenville, shown as lot # 35, on a plat of Magnolia Acres, recorded in Plat Book GG at Page 133, and more particularly shown on a plat of the property of Sylvio Joseph DeSalvo prepared by R. B. Bruce dated September 9, 1961, and according to said plat is described as follows:

BEGINNING at an iron pin on the southern side of Fleetwood Drive, front corner of lot # 34, which pin is 119.4 feet from the intersection of said drive, with Cool Brook Drive; and running thence with the southern side of Fleetwood Drive, N. 64-11 E. 85 feet to iron pin, front corner of lot # 36; thence with line of said lot, S. 25-49 E. 198.3 feet to iron pin in line of lot # 51; thence with the line of said lot, N. 87-21 W. 96.9 feet to iron pin, rear corner of lot # 34; thence with the line of said lot, N. 25-49 W. 152 feet to the point of beginning.
