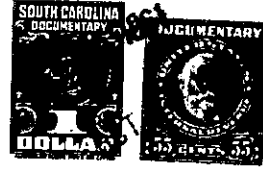

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Allen M. Daigle and Elizabeth P. Daigle, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, in Paris Township, being known and designated as Lot No. 119, as shown on a Plat of Section 2, Bellwood Estates, dated 1955 by Woodward Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book 66, at Page 50, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Bellwood Road, joint front corners of Lots Nos. 118 and 119 and running thence along the line of said lots, N. 73-16 W. 207.1 feet to iron pin; thence running, N. 16-22 E. 80 feet to iron pin rear corner of Lot 120; thence running with line of said lot, S. 73-16 E. 207.6 feet to iron pin on Bellwood Road; thence running with Bellwood Road, S. 16-44 W. 80 feet to iron pin at point of beginning.

NO residence shall be built on any lot costing less than Seven Thousand Five Hundred (\$7,500.00) Dollars; no residence shall be built on said lots nearer than twenty-five (25) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS property is subject to all rights of way.

GRANTEE to pay 1961 taxes.
