unto Levis L. Gilstrap, his Heirs and Assigns Forever:

All those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lots Nos. 13 and 14 Section K of Stone Estates as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "G", at Page 295 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Taber Street at the joint front corner of Lots Nos. 12 and 13 and running thence with the joint line of said lots, S. 78-38 E. 100.8 feet to an iron pin; thence S 11-22 W. 75 feet to an iron pin; thence N. 78-38 W. 52.3 feet to an iron pin; thence along Taber Street, N. 23-20 W. 88 feet to the point of beginning.
