in the State aforesaid, R.M.C. I, Eloise G. Waters, That in consideration of the sum of Seventeen Thousand and No/100 (\$17,000.00) -

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is here-by acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release Lyle J. Hinton and Mary M. Hinton, their heirs and assigns,

"All that piece, parcel or tract of land in Butler Township, Greenville County, State of South Carolina, being located on the southwest side of Greenville and Woodruff Road, and having the following metes and bounds, to-wit:

"BECINNING at an iron pin on the Greenville and Woodruff Road, and running thence S. 23 3/4 W. 11.50 chains to a stone; thence S. 15 1/4 E. 23.83 chains to a stone; thence N. 64 3/4 E. 20.07 chains to a stone on Mrs. Green's line; thence N. 29 1/2 W. 33.00 chains to a stone (red oak gone); thence N. 46 1/2 W. 3.23 chains to a stone at black gum stump; thence S. 13 W. 5.90 chains to the beginning pin, containing 50, acres, more or less.

"Less, however, a 2.87 acre tract heretofore conveyed to Lindsay J. Forrester, Jr. by deed recorded in Book of Deeds 563 at Page 501, leaving a balance of 47.13 acres, more or less."

Being the same property conveyed to the grantor by her late husband, Roy Waters, by deed recorded in Deed Book 575 at Page 443. Roy Waters died testate on October 4, 1959, leaving all of his property to his wife, the grantor herein. (See Apt. 715, File 14, in the Probate Judge's Office for Greenville County).
