All that certain piece, parcel or lot of land situate lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #31, on the southern side of Sylvania Drive, of a subdivision known as Dogwood Terrace, as shown on a plat prepared by J. BEGINNING at an iron pin on the southern side of Sylvania Drive, the joint front corner of lots #31 and #30, and running thence along the line of these lots S. 57-18 W. 150 feet to an iron pin in the property line; running thence N. 32-42 W. 100 feet to an iron pin at the joint rear corner of lots #31 and #32; running thence N. 57-18 E. 150 feet to an iron pin on the southern side of Sylvania Drive; thence along the southern side of Sylvania Drive S. 32-42 E. 100 feet to an iron pin, point of beginning. There being a 10' drainage easement along the joint line of lots #31 and #30.
