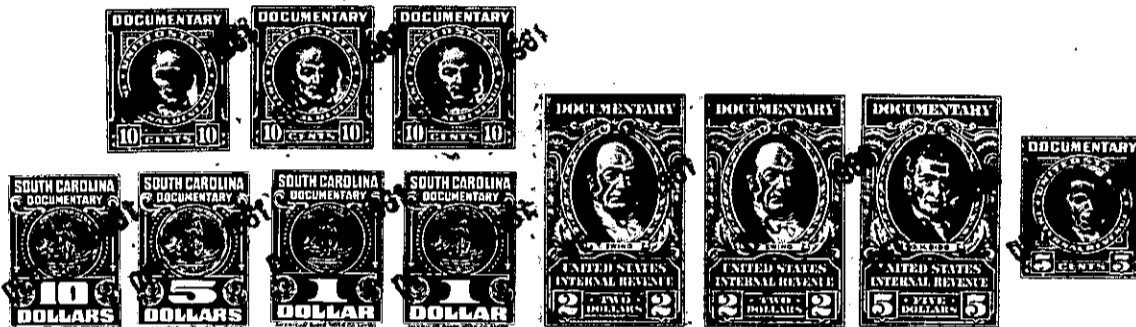
That I, R.D. Wilson,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lula Mae Hooper, her heirs and assigns, forever:

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 19, Section A, on Plat of Oak Hill recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book MM at Page 29, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at a concrete monument on the southeasterly side of Oak Hill Drive, at the joint front corner of Lots Nos. 19 and 20, and running thence with the common line of said lots, S. 40-52 E. 150 feet to an iron pin; thence S. 49-08 W. 75 feet to an iron pin; thence N. 40-52 W. 150 feet to an iron pin on the southeasterly side of Oak Hill Drive; thence with said Drive, N. 49-08 E. 75 feet to the point of beginning.
