to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Elizabeth Chiles Freeman, her heirs and assigns forever,

All my one-half (1/2) interest in and to:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 32 and 33, as shown on a plat of the property of the Charlotte Tripp Subdivision, a portion of Verner Heights, dated July, 1920, and recorded in the RMC Office for Greenville County in Plat Book C at page 267, and having, according to said plat, the following metes and bounds, to-wit:
