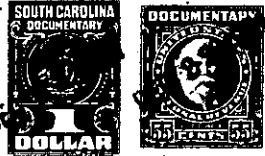

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Jessie Richardson, his Heirs and Assigns forever:

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 80 of Peace Haven, Section No. 1 as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "VV", at Page 83 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Pine Drive at the joint front corner of Lots Nos. 78 and 80 and running thence N. 21-24 W. 148.6 feet to an iron pin; thence along the line of Lot No. 79, S. 60-04 W. 147.4 feet to an iron pin on the eastern side of Pine Drive; thence along the eastern side of Pine Drive, S. 47-37 E. 136 feet to an iron pin at a corner of Pine Drive; thence along Pine Drive, N. 64-57 E. 143.5 feet to the beginning corner.
