A one-fourth undivided interest in and to ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Echo Drive Section "A", Caesars Head Development, more fully described as follows, to-wit: BEGINNING at an iron pin on said drive, corner of lot #57, and running with said drive N 71.07 W 50 feet to a stake; thence with road N 68.20 W 50 feet to a stake; thence the line of lot #61 S 35 W 181 feet 6 inches; thence the line of cliff 150 feet; thence with line of lot #57 N 21.28 E 183 feet to BEGINNING point, and being lot #59 Section "A" Development, as per survey of R.
