BEGINNING at an iron pin in the center of South Carolina Highway No. 296, at the corner now or formerly of Holland, and running thence N. 10-30 W., 152 feet to an iron pin at the corner of Tract No. 2 as shown on said plat; thence with the line of Tract No. 2, N. 23-23 W., 1,029 feet to an iron pin on the southerly side of Maxwell Road; thence with said road, N. 74-20 E., 793 feet to an iron pin; thence around a curve in said road, the chord of which is S. 30-30 E., 64 feet to an iron pin; thence continuing with the curve of said road, the chord of which is S. 37-20 W., 84.5 feet to an iron pin; thence continuing with said road, S. 22-53 E., 142.6 feet to an iron pin; thence S. 13-21 E., 423.1 feet to an iron pin; thence continuing with said road, S. 14-01 E., 275.4 feet to the center of South Carolina Highway No. 296; thence with the center of said highway, S. 61-34 W., 114.3 feet to an iron pin; thence continuing with the center of said road, S. 53-24 W., 100 feet to an iron pin; thence continuing with said road, S. 57-36 W., 604.1 feet to the point of beginning.
