BEGINNING at an iron pin on the northern side of Maxwell Road, at the joint corner of Tracts Nos. 3 and 4 as shown on said plat, and running thence with the common line of said tracts, N. 15-40 W., 1099.7 feet to an iron pin in line of property now or formerly of Don Riddle; thence with Riddle line, N. 77-54 E., 629 feet to a stone at the corner of property now or formerly of Wade Brown, Jr.; thence with Brown line, N. 79-41 E., 401.3 feet to an iron pin; thence S. 15-04 E., 1069 feet to an iron pin on the northerly side of Maxwell Road; thence with the curve in Maxwell Road, the chord of which is N. 80-40 W., 106 feet to an iron pin on the northerly side of said road; thence with said road, S. 74-20 W., 919.3 feet to the point of beginning.
