J. T. Brooks, Jr., his Heirs and Assigns forever:

ALL that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in the Town of Fountain Inn, County of Greenville, State of South Carolina, known and designated as a part of Lot 6 of L. R. Gault property, in accordance with Plat made by J. M. Bryson, Jr., Surveyor, dated March 23rd, 1954, and being more fully described in accordance with said plat, to-wit:
