in consideration of One Thousand Two Hundred and no/100 Dollars,

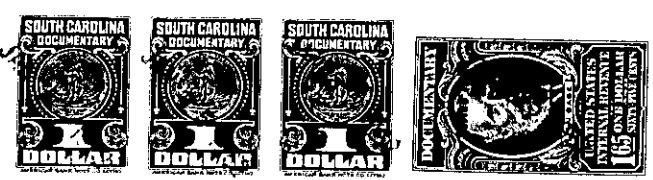
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Larry Foster, his heirs and assigns forever:

All that lot of land in the County of Greenville, State of South Carolina, in Bates Township, known as lot 15 on plat of property of Montevideo, Section II, recorded in plat book MM at page 125, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Echo Lane at the corner of lot 14, and running thence N 62-40 W, 161.7 feet to an iron pin; thence S 20-37 W, 109.3 feet to an iron pin; thence S 70 E, 159 feet to an iron pin on the western side of Echo Lane; thence with said lane, N 21-08 E, 89 feet to the point of beginning and being a portion of the property conveyed to us in deed book 587 at page 217.

This property is subject to the restrictive covenants of record pertaining to Montevideo in deed book 599 at page 75, with the following amendments: That in paragraph 5 thereof, the lot shall be not less than 75 feet wide at the front building set back line and, in paragraph 7 thereof, the building set back line shall be 50 feet; otherwise, the remaining covenants shall apply.
