KNOW ALL MEN BY THESE PRESENTS, that I, Ebbie Mims,

in consideration of Three Dollars, love and affection, - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Isabella Todd, her Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Butler Township, lying north from the road that runs in front of the Rock Hill Baptist Church No. 1, and near the said church, and being a part of the same land that was conveyed to me by deed from James Mims and others November 8th 1961, recorded in the office of the R. M. C. for Greenville County in Deed Book 686 at page 132, and being shown as Lot No. 6 on Plat of Property of Ebbie Mims made by H. S. Brockman, Surveyor, January 10th 1962, and having the following courses and distances, to wit:-

Beginning on an iron pin, joint corner of Lots Nos. 1 and 2 and 5 and 6, and runs thence with the common line of Lots 6 and 5, N. 28-48 E. 291.4 feet to an iron pin on the Johnson line; thence with the said line, S. 60-12 E. 123 feet to an iron pin on said line and being 73 feet from the Clark Johnson corner across a large gully; thence with the common line of this lot and of the Clark Johnson property, S. 30-03 W. 320 feet to an iron pin on the Clark Johnson line and being the joint corner of lots Nos. 1 and 6; thence with the common line of Lots Nos. 1 and 6, N. 46-24 W. 120 feet to the beginning corner.

This lot is subject to one-half of an 18 foot driveway which runs from the above mentioned road along the northern line of Lot No. 3 and then along the common line of Lots Nos. 3, 4 and 2, 5 and 1, 6.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)' heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
