these presents do grant, bargain, sell and release unto the said

Faith Tabernacle, Inc., its successors and assigns,

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, on the northern side of Iola Street, and known and  
designated as Lots 80 and 81 on a plat of "Donwood" recorded in the R. M. C.  
Office for Greenville County in Plat Book A, at page 463, and having the following  
courses and distances:

BEGINNING at a point on the northern side of Iola Street at the corner of Honour  
Property, and running thence along the northern side of said street, N 74-26 E  
100 feet to the corner of Lot 79; thence along the line of that lot, N 15-20 W  
150 feet to the joint rear corner of lots 79, 80, 83 and 84; thence with the  
rear line of Lots 83 and 84, S 74-26 W 100 feet to a point on the line of the  
Honour Property; thence with the line of that property, S 15-20 E 150 feet to  
the beginning.

ALSO, All that certain lot of land in Greenville Township, Greenville County,  
on the southern side of Marion Street, known and designated as Lot 83 on a plat  
of "Donwood" recorded in the R. M. C. Office for Greenville County in Plat Book  
A, at page 463, and having the following courses and distances:

BEGINNING at a point on the southern side of Marion Street at the joint front  
corner of Lots 83 and 84, and running thence with the line of Lot 84 S 15-20 E  
150 feet to the joint rear line of Lots 79, 80, 83 and 84; thence with the rear  
line of lot 80, S 74-26 W 50 feet to the joint rear corner of Lots 83 and 82;  
thence with the line of lot 82, N 15-20 W 150 feet to a point on the southern  
side of Marion Street; thence with the southern side of Marion Street, N 74-26 E  
50 feet to the beginning.
