

Being the same property conveyed to A. L. Pitman by Sallie R. Goodwin by deed dated February _____, 1909, and recorded on February 25, 1909 in the R. M. C. Office for Greenville County in Deed Book 4, Page 36.

Parcel No. 5: ALL that piece, parcel or tract of land, situate, lying in the State and County aforesaid on branch waters of Tiger River, and in Highland Township, and has the following metes and bounds; BEGINNING at a stone, corner of property now or formerly of B. F. Neves; thence N 51 W 3.15 to a large maple on north side of road; thence S 76 W 1.42 ch. to a stake; thence N 71 W 1.38 ch. to a stone; thence along old road, S 53 W 5.60 to a stone; thence S 74½ W 2.20 ch. to a stone; thence S 66½ E 6.40 ch. to a stake in branch; thence up, and with the meanderings of said branch as a line, 26.73 ch. to a willow (dead and down) on left bank of branch; thence N 88½ E 7.75 ch. to a stone on the east side of road; thence N 87½ E 1.67 ch. to a stone; thence N 47½ E 3.00 ch. to a stone; thence N 42½ W 9.50 ch. to a stone; thence N 12 E 19.50 ch. to the beginning corner, containing twenty-nine (29½) and one half acres, more or less.
