Either party may terminate the within and foregoing lease at any time upon giving sixty (60) days prior notice in writing to the other party, and this clause shall inureate the benefit of the owner of the premises.

The covenants and agreements herein contained shall bind, apply to and enure to the benefit of the parties hereto and their respective successors, assigns, and legal representatives.
