the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Bena M. Davis, her heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as lot #8, of a subdivision known as Wellington Green, as shown on a plat thereof prepared by Piedmont Engineering Service, dated September 1961, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 29, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Melbourn Lane, the joint front corner of lots #8 and #9, and running thence along the line of these lots, N. 28-40 E. 162.3 feet to an iron pin in the property line; running thence S. 59-53 E. 84.5 feet to an iron pin at the joint rear corner of lots #8 and #7; running thence S. 37-53 W. 157.8 feet to an iron pin on the northern side of Melbourn Lane; running thence along the northern side of Melbourn Lane S. 53-40 E. 62.7 feet to an iron pin; thence continuing along the northern side of Melbourn Lane S. 59-37 E. 47.3 feet to an iron pin, point of beginning.

The above described lot is a portion of that property conveyed to me by Cora C. Howell by her Deed dated April 9, 1914, and recorded in the R.M.C. Office for Greenville County in Deed Vol. 60, at Page 130.

It is understood and agreed that this conveyance is subject to certain restrictions and protective covenants applicable to Wellington Green Subdivision recorded in the R.M.C. Office for Greenville County in Vol. 685 at Page 135.
