KNOW ALL MEN BY THESE PRESENTS, THAT I, Dessie M. Ellison

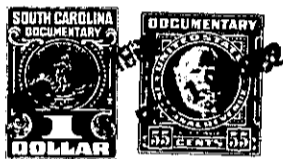
in consideration of the sum of Two Hundred and Seventy Five and 00/100-----(\$275.00)----- DOLLARS,

B. G. Trotter and Ollie F. Trotter, their heirs and assigns, forever:

all that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, on the E/S of the South Saluda river, near Phillips Lake, being shown as Lot no. fifteen (15) on a plat of survey made by Robert B. Bruce, surveyor, 1957, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING on the joint corners of Lots 14 and 15 on the W/S of a County Road and running with the common line of said lots, N. 75-00 W., 123.7 feet to a point of the bank of the South Saluda river; thence following said river, N. 23-48 E., 130.6 feet to an iron pin; thence S. 46-55 E., 86.5 feet to a point in said County Road; thence following said road, S. 05-07 W., 100 feet to the point of beginning, being subject to such right-of-ways or easements as may have been previously given.
