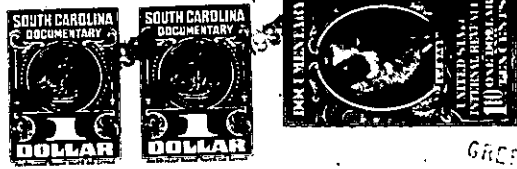

unto Elizabeth B. Strickland, her heirs and assigns,

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 25, Spring Brook Terrace, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book KK, page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Miami Avenue, joint front corner Lots 23 and 25; and running thence S. 2-00 E. 155.1 feet to an iron pin; thence N. 85-03 E. 70.4 feet to an iron pin; thence N. 2-00 W. 163.7 feet to an iron pin on Miami Avenue, joint front corner Lots 25 and 27; thence along Miami Avenue S. 88-00 W. 70 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the Grantee assumes and agrees to pay, according to its terms, that certain note and mortgage given to Carolina Federal Savings & Loan Association on which there is a balance due of \$8,400.00, said mortgage being recorded in the RMC Office for Greenville County, S. C. in Mortgages Volume 877, page 364.
