to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said CHARLES E. ROBINSON, his heirs and assigns, forever:

ALL that piece, parcel or tract of land, situate on the Southeast side of Riverview Drive, near the City of Greenville, in Greenville County, S. C., shown as Lot No. 119 on plat of Riverdale, made by Dalton & Neves, Engineers, July 1957, recorded in the RMC Office for Greenville County, S.C. in Plat Book KK, page 107, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of Riverview Drive, at joint front corner of Lots 118 and 119, and runs thence along the line of Lot 118, S. 51-28 E. 224 feet to an iron pin; thence N. 27-10 E. 65 feet to an iron pin; thence with the line of Lot 120, N. 26-51 W. 190.6 feet to an iron pin on the Southeast side of Riverview Drive; thence with the curve of Riverview Drive (the chord being S. 49-48 W. 100 feet) to an iron pin; thence still with the curve of Riverview Drive (the chord being S. 40-41 W. 50 feet) to the beginning corner.

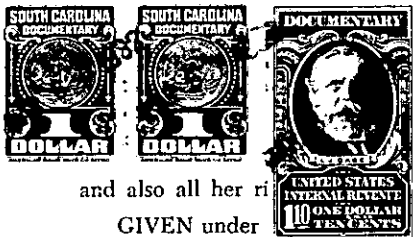
