to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Nina S. Wilson and Merrill C. Wilson, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the southeasterly side of Dreamland Way, near the City of Greenville, S. C., and being shown as Lot No. 3 on the plat of the property of Ruth H. Jamison made by C. C. Jones, Registered engineer, dated April, 1951, and having according to said plat, which is recorded in Flat Book T, page 326, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Dreamland Way, joint front corner of Lots Nos. 2 and 3, and running thence along the common line of said lots S 31-40 E 322.5 feet to an iron pin, joint rear corner of Lots 2 and 3, and also in line of property now or formerly of Howard; thence along the Howard line S 66-39 W 100 feet to an iron pin, joint rear corner of Lots 3 and 4; thence along the common line of said Lots N 31-40 W 321.3 feet to an iron pin on the southeasterly side of Dreamland Way; thence along said Way N 65-56 E 100 feet to an iron pin, the point of beginning.
