the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Nannie Mae Pratt, her heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 20, as shown on a Plat of Laurel Hills by W. N. Willis, Engineers, dated March 1960 and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 33, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Laurel Drive, joint front corners of Lots Nos. 18 and 20 and running thence along the line of said lots, S. 0-30 W. 143.2 feet to iron pin rear corner of Lots 17 and 19; thence running with rear line of Lot 19, N. 81-53 E. 85 feet to iron pin rear corner of Lot 22; thence running with line of said lot, N. 0-30 E. 165.7 feet to iron pin on Laurel Drive; thence running with Laurel Drive, S. 68-33 W. 96.8 feet to iron pin at point of beginning.

NO residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty (30) feet, or the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
