GENERAL PERMIT

(CORPORATION) Form 8417 Nov. '54 No. 100

Received of the SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY ONE AND _____ Dollars, in consideration of which Greenville County School District hereby grants said Company, its associated and allied companies, their respective licensees, successors and assigns, the right to construct, operate and maintain a line of communication consisting of such poles, wires, cables, conduits, guys, anchors and other necessary appurtenances as from time to time are required upon, across, and/or under that certain tract of land situated in Greenville County, State of South Carolina, to-wit: THAT TRACT OF LAND LYING SOUTH OF BERCA DRIVE AND WEST OF BERCA LIONS CLUB ROAD AND BOUNDED ON THE N.E. BY CHARLES HAWKINS ON THE WEST BY MRS. ROBERT WELLS ON THE S.E. BY G.W. HAWKINS. and upon, along and under the roads, streets, or highways adjoining or through said property with the right to permit the attachments of and/or carry in conduit wires and cables of any other person or company for communications purposes or for the transmission and distribution of electric power and the right of ingress and egress to said premises at all times for the purpose of inspecting and maintaining said line and with the right to clear and keep cleared all trees, undergrowth or other obstructions within a strip of land 8 feet on each side of the center of said line and to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees which might reach said line in falling; including the right to relocate said line on said premises to conform to any future highway relocation, widening or improvement; the said sum being received in full payment for the rights herein granted.
