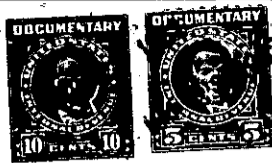

Know All Men by These Presents:

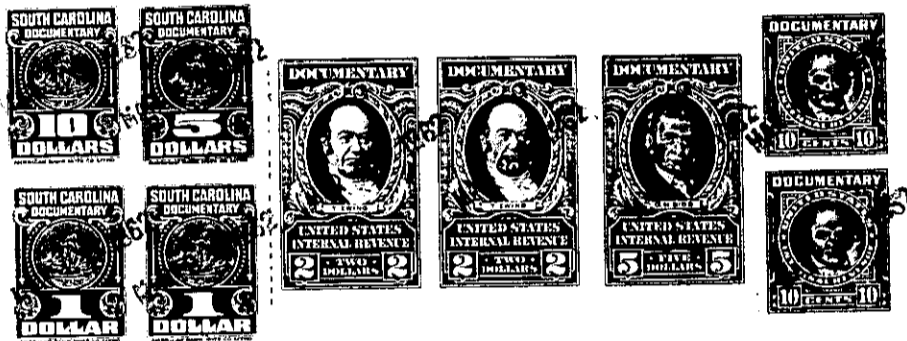
That I, R.D. Wilson

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 18, Section A, on a plat of Oak Hill recorded in the R.M.C. Office for Greenville County in Plat Book MM at Page 29, and having, according to a revision thereof recorded in Plat Book ZZ at Page 39, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Oak Hill Drive at the joint front corner of Lots Nos. 17 and 18 as shown on said revision, and running thence with the common line of said lots, S. 32-32 E. 170.4 feet to an iron pin; thence N. 49-08 E. 120 feet to an iron pin; thence N. 40-52 W. 150 feet to an iron pin on the southeasterly side of Oak Hill Drive; thence with said Drive, S. 59-11 W. 67 feet to the point of beginning.
