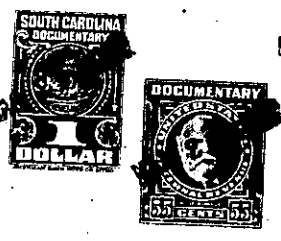

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Douglas F. Langley, his Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, on the southeastern side of Paris View Drive and being known and designated as Lot No. 14 on plat of property of H. G. Stevens recorded in the R. M. C. Office for Greenville County in Plat Book "M", at Page 9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Paris View Drive at the joint front corner of Lots Nos. 13 and 14 and running thence along said Drive, N. 35 E. 70 feet to an iron pin; thence along the joint line of Lots Nos. 14 and 15, S. 51-55 E. 322.8 feet to an iron pin; thence S. 35 W. 70 feet to an iron pin; thence N. 51-55 W. 322.8 feet to the point of beginning.
