unto Hassie B. Eberhardt, her heirs and assigns forever:

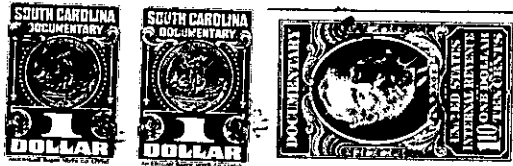
